


#### FTC Taking Action, Finally!

- ✓ June 8, 2022: FTC adopts (6)(b) study, vote 5-0!
  - ✓ Scrutinizing PBMs business practices
  - ✓ Examining the impact of PBM practices
  - √ FTC sending compulsory orders
  - ✓ Move came after more than 24,000 public comments were submitted in response to the FTC's request for information
  - ✓ Update: Expanded study to include GPOs and rebate aggregators
- ✓ Chairwoman Lina Khan spoke at NCPA Annual Convention

#### **Congressional Focus on PBMs**

- May 23rd: Chairman James Comer (R-KY), House
   Oversight and Accountability Committee, held a hearing
   investigating PBM practices-NCPA Member Kevin Duane
   testified House
- May 17th: House Ways and Means Health Subcommittee held a hearing on PBM practices - NCPA member Joe Moose testified
- Senate Judiciary, Senate Commerce, Senate HELP, House Energy and Commerce, and House Education and Workforce committees have already marked-up PBM legislation
- Senate Finance held a hearing on PBMs
- House Energy and Commerce held a hearing on Price Transparency with a focus on PBMs
- HHS Secretary Becerra asked about PBMs in numerous budget hearings

#### NCPA's Congressional PBM **Reform Priorities**



H.R. 1613 / S. 1038, the Drug Price Transparency in Medicaid Act

• Included in H.R. 3561, the Promoting Access to Treatments and Increasing Extremely Needed Transparency (PATIENT) Act



S. 127, the Pharmacy Benefit Manager Transparency Act



H.R. 2880, the Protecting Patients Against PBM Abuses Act



S. 2052, the *Protect Patient Access to Pharmacies Act* 





H.R. 1613/S. 1038, the Drug Price Transparency in Medicaid Act of 2023

- Sponsored By Reps. Carter (R-GA) and Gonzalez (D-TX) in House and Sens. Welch (D-VT) and Marshall (R-KS) in Senate
  - Additional House leads: Reps. Rick Allen (R-GA), Jake Auchincloss (D-MA), Elise Stefanik (R-NY), and Deborah Ross (D-NC.)



- Federal "fix"
- Prohibits spread pricing
- "Pass-through" model
- NADAC & dispensing fee
- PBMs would be paid an administrative fee

CBO has estimated over \$1 billion in savings over 10 years

#### The PATIENT Act (H.R. 3561)

Includes provisions vital to lowering prescription drug costs and bringing transparency to anticompetitive practices of PBMs, including H.R. 1613

### Passed committee in a unanimous 49-0 vote

### The Pharmacy Benefit Manager Transparency Act (S.127)

- Bans deceptive unfair pricing schemes, including spread pricing and arbitrary clawbacks
- Requires PBMs to report to the FTC revenue made through spread pricing and pharmacy fees
- NCPA-led amendment from Sens. Tester & Capito ensures that clawbacks are completely banned
- Passed out of Commerce Committee on a bipartisan 18-9 vote

## Protecting Patients Against PBM Abuses Act (H.R. 2880)

- Introduced, referred to House E&C, W&M committees: April 26
- Prohibit PBMs from reimbursing non-affiliated pharmacies at a rate less than they reimburse their own pharmacies → removing incentives to steer patients
- Delink PBM compensation from the cost of medications so that PBMs are no longer benefiting from ever increasing list prices and rebates.
- Prohibit spread pricing in the Medicare Part D program.
- Increase transparency by requiring PBMs to publicly report all rebates and fees they receive from drug manufacturers.

#### DIR Reform: The Fight Continues

Changes were delayed until January 1, 2024

Continued vigilance of PBM behavior

Amount and timing of payments and adjustments

But pharmacies should know concessions up front

How will pharmacies know their lowest possible reimbursement?





### Protect Patient Access to Pharmacies Act (S. 2052)

- Ensures that, at a minimum, a pharmacy's costs to acquire and to dispense a covered Part D drug to beneficiaries are covered;
- Standardizes and oversees the metrics PBMs and plans use to measure pharmacy performance and quality and ensures they are fairly applied, rewarding PBMs/plans for compliance; and
- Strengthens transparency in PBM payments to pharmacies.

#### Other Vital Federal Updates

#### **Senate HELP Committee PBM Legislation**

- NCPA has concerns with the HELP legislation (S. 1339, the Pharmacy Benefit Manager Reform Act) that could preempt state victories that reign in harmful PBM practices.
- 2,000 organizations/businesses demand Congress to preserve the status quo on ERISA preemption

#### **Senate Finance Committee PBM Legislative Framework**

- Senate Finance PBM Framework: NCPA thanks Chairman Wyden & Ranking Member Crapo for their bipartisan framework to address PBMs and lower drug costs. NCPA will work with the committee to remove hurdles to pharmacy access by advancing spread pricing reform in Medicaid, finalizing DIR fee reform, and modernizing any willing pharmacy provisions.
- Committee markup taking place on July 26, 2023





#### **Provider Status Legislation**

#### The Equitable Community Access to Pharmacist Services Act (H.R. 1770)

- Ensures patients can continue to access COVID-19 pandemic and pandemic-related health services from pharmacists and provide payments for these services
- Part B Coverage for the following:
  - COVID and flu-vaccine administration
  - COVID, flu, strep and RSV-testing
  - COVID, flu and strep- treatment

#### Pharmacy and Medically Underserved Areas Enhancement Act (S. 1491)

 Authorizes Medicare payments for pharmacist services in states that already authorize them

 Continued advocacy alongside partners and members

 NCPA joined the EMPOWER Patients Florida coalition, a savvy media campaign

# PBM Enforcement: NAIC Collaboration

#### PBM draft white paper

- NCPA submitted comments co-signed by 79 organizations.
- Comments focused on tools and resources for enforcement
  - PBM-specific expertise on staff
  - PBM-specific complaint forms
- Urged strengthening language to reflect recent court victories
- Advocated for uniform PBM enforcement when state law is silent on ERISA

#### **PBM Enforcement: In the States**

 Some state PBM regulators are taking active steps to preemptively enforce regulations







- Arkansas, West Virginia, and Tennessee now have laws tying reimbursement rates to acquisition costs (e.g., NADAC).
- Ongoing campaign to urge pharmacies to contact state regulators to inform them of violations and other anticompetitive PBM practices.





#### PBM Enforcement: Advocacy

- DOI Complaint resource: NCPA resource to help members file complaints with their state insurance regulators
- Advocating to NAIC for uniform statelevel and PBM-specific complaint form
- NCPA to develop similar tool to facilitate patient complaints in the pharmacy

#### Scope of Practice/Compensation

#### Adopting HHS authorizations post PHE

CLIA-waived tests and expansion of vaccine authority

Payment parity bills (via Medicaid and/or commercial plans)

Provider Status (i.e. PrEP/PEP, hormonal contraceptives, tobacco cessation etc.)





#### **Expanding Scope of Practice**

### NCPA continues to advocate for pharmacists to practice at the top of their license including

- Administering hormonal contraception
- HIV PEP/PrEP medications
- Tobacco cessation
- Long acting injectables, et al.











#### **Expanding Scope of Practice: Bills of Note**

#### **Arkansas:**

HB 1007 allows pharmacists to provide HIV PEP/PrEP medication pursuant to a statewide protocol

#### **Indiana**:


HB 1568 allows pharmacists to be prescribe and dispense "selfadministered hormonal contraceptives" and pharmacists are eligible under Medicaid for reimbursement for these services

#### **New Jersey:**

SB 275 permits pharmacists to furnish self-administered hormonal contraceptives pursuant to a standing order with protocols established by the state Board of Pharmacy and **Board of Medical Examiners** 



# PREP Act Vaccine and Testing Authorities Among the States



#### **Recent State Actions**

<u>Delaware</u> – authorizes pharmacists to test & treat flu, strep, COVID and other conditions


<u>Kansas</u> – allows pharmacists to initiate testing for flu, strep, UTI's

Montana – allows pharmacists to administer vaccines to individuals over 6 years of age

Virginia – permits pharmacists to administer ACIP & CDC recommended vaccines



# PREP Act Vaccine and Testing Authorities Among the States



Only 12 states have fully enacted the PREP Act authorities.





# Provider Status and Payment for Services

#### **Maryland**

Requires public and private plans to provide coverage for services rendered by a pharmacist within their scope of practice

#### **Wyoming**

Authorizes payment for pharmacy services under Medicaid.

#### Virginia

Pharmacy services are eligible for reimbursement under Medicaid

Maryland becomes the 9<sup>th</sup> state to cover services within pharmacy scope of practice for both commercial and private insurers. Wyoming and Virginia are the 12<sup>th</sup> and 13<sup>th</sup> states to provide reimbursement for pharmacy services under the state Medicaid plan.




